WHY

The Wisconsin United Methodist Foundation (WUMF) exists to assist the ministries of United Methodists in Wisconsin through lifelong financial stewardship. In addition, Saving Grace small groups are a great way for a church to make an initial connection with people from their community in a way that addresses people's needs.

PHASE 1

Attend all nine sessions of the nine week Saving Grace virtual small group and complete the work in the workbook. Upon completion:

- Each participant will receive a \$25 completion gift (up to \$50 per participating couple).
- Each participant will receive full reimbursement for the Saving Grace clergy workbook and devotional (submission of purchase receipt required).
- Each church will be reimbursed the cost of the Saving Grace Leader Kit, if the pastor's congregation decides to purchase and use the material in their local church (submission of purchase receipt required).
- Each church that purchases the Saving Grace Leader Kit for use in their local church will receive \$200 for promoting their first Saving Grace small group in their local community.

PHASE 2

Complete one Saving Grace small group in your local church and submit a short report detailing the group members' experience and the difference it made in participants lives (preferably with quotes from small group members and a few pictures).

• Each church that submits the above report will receive an additional \$250 grant for their Stewardship ministries.
